

# CPP30115 Certificate III in Urban Pest Management

Our CPP30115 Certificate III in Urban Pest Management has been designed to train students how to competently and safely:

- ❖ identify general and timber urban pests
- ❖ assess pest problems
- ❖ consider pest management options
- ❖ develop pest management plans
- ❖ liaise with customers
- ❖ implement pest management strategies



In most cases, the technician will work alone and have responsibility for managing chemicals and equipment used in pest management as well as for a pest management vehicle, including the vehicle storage area.

## Course Entry

**General entry requirements:** include a Unique Student Identifier (USI) number and a Language Literacy and Numeracy (LLN) assessment (if deemed required).

**Work Placement:** To ensure our students can apply their training in an industry environment, Rapid Training requires all students to either be **employed** or have **pre-arranged & documented work placement\***, under an accredited technician. During the placement the student must complete a logbook of 25 General Pest inspections & applications, and 10 timber pest inspections & (minimum) 1 timber pest treatment.

*\*The Work Placement Agreement form, signed by the accredited technician, must be submitted during enrolment to confirm work placement.*

## Course Outcomes

Successful completion of this course students will have the ability to comprehensively apply their knowledge and skill across the operations of the pest business for growth.

Completing students will be issued a national recognised Certificate. Prior to enrolment and upon completion, please consult your state's [licencing authority](#) on their license requirements.
